

How to obtain source materials inexpensively

Source materials are basic to all research. Unfortunately, in many cases such materials are inordinately expensive to obtain and to house due both to scarcity and to bulk. The result is the accumulation of sources at various points so that Professor A must travel to Institution B in order to use Source C, which is housed there.

Is there a solution to this problem? Yes, a simple one—miniaturize the information so that it can be reproduced and distributed inexpensively.

We are in the business of issuing books, journals, reports, manuscripts, technical data, etc., in miniaturized form using opaque (Microcard) and transparent (microfiche) cards on which materials have been reduced to approximately 1/18th their original size. We invite your inquiries with regard to how miniaturization can make source materials and the results of research more widely available.

What has been done to date?

In history and political science: *The French Journal* and the debates of the German Reichstag are currently being reproduced along with other source materials for the study of modern European history.

In psychology: Unprocessed and uninterpreted tests (e.g., Rorschach, TAT) given to individuals outside the main stream of western culture (e.g., Eskimos, Navahos) have been made available to researchers under the title *Primary Sources in Culture and Personality*.

In international relations: *The Official Documents* of the Organization of American States have been issued in miniaturized form since 1961.

In literature: *Early English Text Society Publications*, *Chaucer Society Publications*, *Shakespeare Society Publications*, are among the many basic sets containing primary source materials that have been reprinted on Microcard and microfiche.

In chemistry: U. S. chemical patents are supplied on microfiche at 4¢ per patent—85% less than the 25¢ charged for patents in their original form plus a space saving of 95%.

In physics: Unclassified reports of the U. S. Atomic Energy Commission are available on Microcard and microfiche. These reports (over 50,000 to date) comprise a substantial portion of the world literature on atomic energy as the technical report is the principal form in which results of research and development by the AEC and its contractors are recorded.

In linguistics: *The Index to Rimes in American and English Poetry*, a file of over 100,000 5"x8" cards, was the result of a project to study changing pronunciations by recording how poets rimed words with selected key words over a three-century period. For many years this information was available only to scholars able to travel to the university housing the cards, but their reproduction on Microcard has permitted all interested universities to obtain this valuable source for advanced research in linguistics and allied fields.

In mathematics: *The First Six Million Prime Numbers*, the largest list of prime numbers ever issued, was published exclusively on Microcard, as by no other method could the thousands of pages of computer print-out be made available inexpensively.

In short, miniaturization of this type is most useful when there is a need to distribute a vast quantity of information to a limited number of people. Perhaps you have such a project in mind. If so, let us hear from you.
