New Writing from the Philippines

A Critique and Anthology

Leonard Casper

In this, the first extended critical study of Philippine writing in English to be published in the United States, Leonard Casper has produced a volume of unusual richness, perception, and authority.

Casper begins his "Critique" with a brief history of the Philippines and its effect on the Philippine cultural and literary climate. In the two critical chapters, "Folk Culture and City Commerce: Confrontations" and "A People of Many Pasts and Complex Parts," he discusses with illuminating sensitivity some thirty of the best contemporary Philippine writers and the many conflicting influences on their work.

For the anthology which follows, Casper made his selection of nearly forty pieces on the basis of literary quality and inaccessibility to an American audience. The selections include an essay, short stories, poems, and a play, *Portrait of the Artist as Filipino* by Nick Joaquin, which has not been available in print even in the Philippines for over ten years, but which has been recently filmed and is the official Philippine entry in the 1966 Venice Film Festival. Other writers represented in the anthology include Carlos P. Romulo, Arturo B. Rotor, Jose Garcia Villa, and Manuel A. Viray.

Casper, recognized as our foremost scholar in modern Philippine literature, has included a selected bibliography of Philippine literature in English, a checklist of all Philippine literature published in America since 1930, and a glossary-index that, he hopes, "will contribute to an understanding beyond textual illumination."
