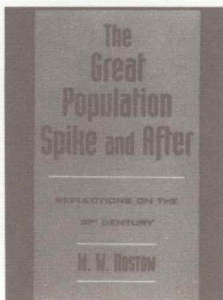
THE POLITICS OF PLANNING
