Father Carroll systematically interviewed the Filipino founders, or persons close to the founders, of more than a hundred manufacturing concerns which in 1960 employed one hundred or more workers. He investigated the social origins of the entrepreneurs and their families, their careers before establishing their businesses, and the ways in which they founded and managed the enterprises. His study concludes with some theoretical reflections on the relationship between economic and social factors in the backgrounds of the businessmen and analyzes the strengths and weaknesses of this type of entrepreneurial development.

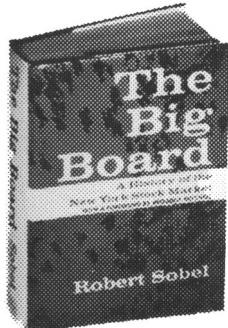

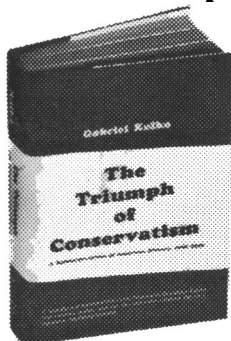

Here are the sober thoughts and observations of a lifetime’s familiarity with Latin America. Demonstrating how the situations in Latin America defy standard interpretations, Professor Gordon first presents the *facts* about the state of economic affairs and then derives some important conclusions. Noting that land ownership is often associated with prestige and social position, Gordon shows how ineffectually it is used and how an attitude is engendered which regards any stock or bond ownership as “paper wealth.” Gordon shows, too, that in spite of financial aid extended by both the United States and Western Europe, there is a net export of capital to those very same countries from Latin America each year.

In seeking the proper path to economic security and growth for Latin America, the author insists that the primary task is to create institutions indigenous to the region — institutions which would be uniquely suitable to the social, political, and economic circumstances of these nations.

This book should prove a valuable aid to all those concerned with trade and investment in Latin America.
