**BARRY CARR** is Senior Lecturer in Latin American History at La Trobe University in Melbourne, Australia. He is the author of *El movimiento obrero y la política en México, 1910–1929* (1976) and has written several articles on twentieth-century Mexico.

**MARK WASSERMAN** is Professor of History at Douglass College of Rutgers University.
