CLAY CLEMENS is Chancellor Professor of Government at the College of William and Mary (Government Department, Tyler Hall, 300 James Blair Drive, Williamsburg, VA 23187; email: cmclem@wm.edu). Besides publishing numerous articles on German politics, he is the coeditor of *The German Election of 2005* (with Thomas Saalfeld, 2007) and *The Kohl Chancellorship* (with William Paterson, 1998), as well as the author of *Reluctant Realists: The CDU/CSU and West German Ostpolitik, 1969-1982* (1989).

RONALD J. GRANIERI is a senior fellow at the Foreign Policy Research Institute (1528 Walnut Street, Suite 610, Philadelphia, PA 19102; email: rgranieri@fpri.org), where he is director of the Center for the Study of America and the West. He is also the director of research at the University of Pennsylvania's Joseph H. Lauder Institute of Management and International Studies. Granieri is the author of *The Ambivalent Alliance: Konrad Adenauer, the CDU/CSU, and the West, 1949-1966* (2003), as well as of numerous scholarly articles on German history, European-American relations, the Cold War, and contemporary politics. Granieri is currently completing a book tentatively titled "Between Europe and the Nation: German Christian Democracy from Détente to Reunification."

MATHIAS HAEUSSLER is Lumley Research Fellow at Magdalene College, University of Cambridge (Magdalene Street, Cambridge CB3 0AG, United Kingdom; email: mhh29@cam.ac.uk). He has published widely on Helmut Schmidt and postwar German history in journals such as *European Review of History*, *Cold War History*, and *The International History Review*. He is currently completing his first monograph on Helmut Schmidt and British-German relations, a revised version of his doctoral thesis, which won the 2017 British International History Group's thesis prize.

ELIZABETH B. JONES is professor of history at Colorado State University (Department of History, Clark B-343, Colorado State University, Ft. Collins, CO 80523-1776; e-mail: elizabeth.jones@colostate.edu). She is the author of *Gender and Rural Modernity: Farm Women and the Politics of Labor, 1871-1933* (2009). Her current book project, "Reclaiming Germany's Wild West: Internal Colonization and Empire," investigates the social, environmental, and political aspects of German internal colonization in the nineteenth and twentieth centuries. Recent publications related to this research have appeared in *Geschichte und Gesellschaft*, *Agricultural History*, *Historia Social*, and *The International Journal for History, Culture and Modernity*.

LARRY EUGENE JONES is professor of history emeritus at Canisius College in Buffalo (Department of History, 2001 Main Street, Buffalo, NY 14208-1035; email: jones@canisius.edu). His primary field of research is the political history of the Weimar Republic and Third Reich, and he is the author of *German Liberalism and the Dissolution of the Weimar Party System, 1918-1933* (1988), as

well as *Hitler versus Hindenburg: The 1932 Presidential Elections and the End of the Weimar Republic* (2016). Jones has edited or coedited seven books, including *The German Right in the Weimar Republic: Studies in the History of German Conservatism, Nationalism, and Antisemitism* (2014), and *From Weimar to Hitler: Studies in the Dissolution of the Weimar Republic and the Establishment of the Third Reich, 1932-1934* (coedited with Hermann Beck, forthcoming).

CASSANDRA PAINTER is a PhD candidate in modern German history at Vanderbilt University (2301 Vanderbilt Place, PMB 351802, Nashville, TN 37235; email: cassandra.l.painter@vanderbilt.edu). A Jacob K. Javits Fellow and Fulbright Scholar, she was a fellow-in-residence in 2016-2017 at the University of Notre Dame's Institute for Advanced Study. Her doctoral dissertation examines the life and subsequent cult of veneration of stigmatic and visionary Anna Katharina Emmerick (1774-1824), looking at the ways in which German Catholics created meaning and built community in modern Germany.

GAVRIEL D. ROSENFELD is a professor of history and director of the undergraduate program in Judaic Studies at Fairfield University (Department of History, Canisius Hall, Fairfield University, Fairfield, CT 06824; email: GRosenfeld@fairfield.edu). He is the author or editor of six books, including *What Ifs of Jewish History: From Abraham to Zionism* (2016); *Hi Hitler! How the Nazi Past is Being Normalized in Contemporary Culture* (2015), which won the German Studies Association's Sybil Halpern Milton award for best book on the subject of Nazism and the Holocaust; and *Building after Auschwitz: Jewish Architecture and the Memory of the Holocaust* (2011), which was a finalist for the National Jewish Book award in the category of art and architecture. He is an editor of the journal *Dapim: Studies on the Holocaust*, and his next book, *The Fourth Reich: A History*, will appear in 2019.

MARY ELISE SAROTTE is the Kravis Distinguished Professor of Historical Studies at the School of Advanced International Studies at Johns Hopkins University (SAIS, 1740 Massachusetts Ave., NW, Washington DC, 20036; email: sarotte@jhu.edu). She is the author or editor of five books, including *The Collapse: The Accidental Opening of the Berlin Wall*, and *1989: The Struggle to Create Post-Cold War Europe*, both of which were named "Books of the Year" by the *Financial Times*. A former White House Fellow and member of the Institute for Advanced Study in Princeton, she is a research associate at the Center for European Studies at Harvard University and a member of the Council on Foreign Relations.

KRISTINA SPOHR is associate professor of international history at the London School of Economics and Political Science (International History Department, Sardinia House 2.17, LSE, Houghton Street, London WC2A 2AE, United Kingdom; email: k.spohr@lse.ac.uk). She is the author or editor of five books, including *Germany and the Baltic Problem after the Cold War: The Development of a New Ostpolitik 1989-2000* (2004); *The Global Chancellor: Helmut Schmidt and the Reshaping of the International Order* (2016) (which appeared in an extended German edition, *Der Weltkanzler* [2016]); and *Transcending the Cold War: Summits, Statecraft and the Dissolution of Bipolarity in Europe, 1970-1990* (coedited with David Reynolds, 2016). She is currently completing a book on the global exit from the Cold War between 1989 and 1992, with the financial support of the

Leverhulme Trust. For the 2018–2019 academic year, Spohr will join the Johns Hopkins School of Advanced International Studies (SAIS) as the inaugural Helmut Schmidt Distinguished Professor at the Henry A. Kissinger Center for Global Affairs.

CHRISTIAN WICKE is an assistant professor in political history at Utrecht University (Department of History & Art History, Utrecht University, Drift 6, 3512 BS Utrecht, Netherlands; email: c.wicke@uu.nl). The author of *Helmut Kohl's Quest for Normality: His Representation of the German Nation and Himself* (2015), Wicke has published articles on nationalism, social movements, and industrial heritage. With Stefan Berger and Jana Golombek, he coedited a special issue of *The Public Historian* in November 2017, titled “Deindustrialization, Heritage, and Representations of Identity,” as well as the volume *Industrial Heritage and Regional Identity* (2018). He is currently studying the history of urban movements in the 1970s.

Editorial Policy

Central European History publishes articles, review essays, and book reviews that range widely through the history of Germany, Austria, and other German-speaking regions of Central Europe from the medieval era to the present. All topics and approaches to history are welcome: cultural, social, political, diplomatic, intellectual, economic, and military history, as well as historiography and methodology. Contributions that treat new fields, such as post-1945 and post-1989 history, maturing fields such as gender history, and less-represented fields such as medieval history and the history of the Habsburg lands are especially desired. The journal thus aims to be the primary venue for scholarly exchange and debate among scholars of the history of Central Europe. Because space is limited, articles that have been or soon will be published elsewhere are not accepted. Manuscripts submitted to CEH should not be under consideration by another journal pending decision of the editor on publication. If it is learned that an article is under submission to another journal while being considered at CEH, consideration will cease immediately. Unsolicited book reviews are not accepted.

The editor prefers that manuscripts be submitted via ScholarOne (<https://mc.manuscriptcentral.com/ccc>). Please take care to remove author identifying information, following the prompts in ScholarOne, to make your manuscript anonymous. The entire text of all manuscripts, including endnotes and headings, must be prepared in double-spaced typescript with generous margins to allow for copyediting. Endnotes must be numbered consecutively and should be placed in a separate section at the end of the text.
