GERMAN SOCIAL DEMOCRACY AND THE RISE OF NAZISM

In *German Social Democracy and the Rise of Nazism*, Donna Harsch explores the failure of Germany's largest political party to stave off the Nazi threat to the Weimar republic. She looks closely at Social Democratic ideology, structure, and political culture, examining how each impinged upon the party's response to economic disaster, parliamentary crisis, and the Nazis. She considers political and organizational interplay within the SPD as well as interaction between the party, the Socialist trade unions, and the republican defense league. Conceding that lethargy and conservatism hampered the SPD, Harsch focuses on strikingly inventive ideas put forward by various Social Democrats to address the republic's crisis and shows that the unresolved competition among these proposals blocked innovations that might have thwarted Nazism.
