During the preceding 12 months (through October 6, 1986) the average number of copies printed for each issue was 3,588; the average paid circulation, 3,283; the average free distribution, 35; the average number of copies distributed 3,318. Corresponding figures for the last issue before filing: 3,603 total number of copies printed; 3,302 total paid circulation; 37 free copies distributed; 3,603 total distribution.
