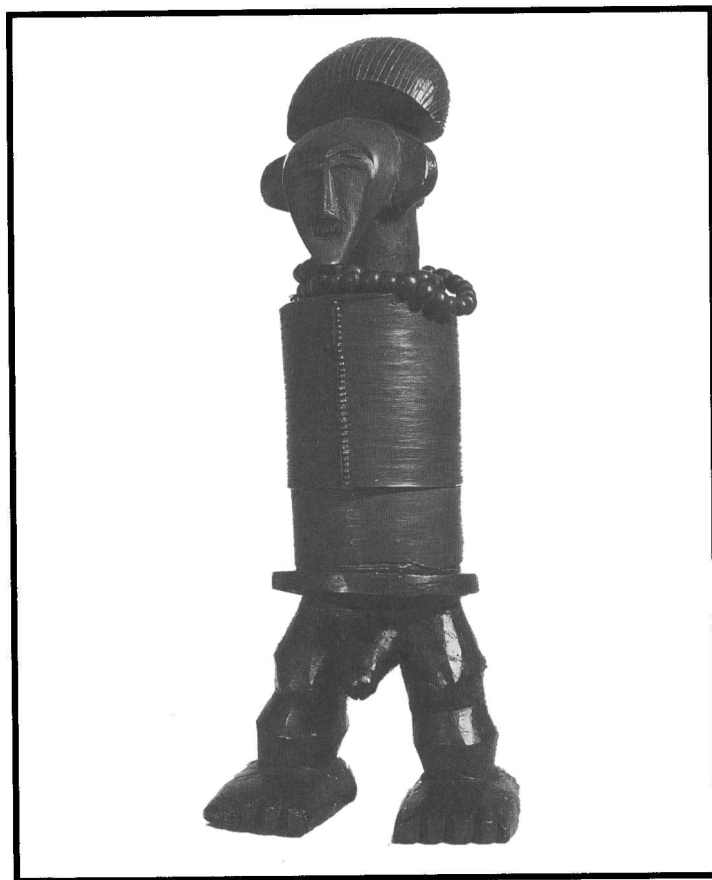

ASR will only consider unpublished manuscripts.**

GORAN HYDEN is Professor of Political Science at the University of Florida since 1986 and served as Interim Director of its Center for African Studies 1994-1996. He is currently Past President of the African Studies Association.

STEPHEN ELLIS is a senior researcher at the Afrika-studiecentrum, Leiden, the Netherlands. A historian, he is the author or co-author of five books on the history and politics of various African countries.

JANET MACGAFFEY is Associate Professor of Anthropology at Bucknell University, Lewisburg, Pennsylvania. She has done research on Zaire, and is the author of *Entrepreneurs and Parasites: the Struggle for Indigenous Capitalism in Zaire*, and co-author of *The Real Economy of Zaire*.

JOHN D. HOLM is Director of International Programs and Professor of Political Science at Cleveland State University. He has done field work and written on democracy in Botswana since 1970. He was the first Coordinator of the Democracy Research Project at the University of Botswana.

PATRICK P. MOLUTSI is a Lecturer in Sociology at the University of Botswana and a former Coordinator of the Democracy Research Project at the University. He has written extensively on the politics of Botswana, particularly with respect to rural development.

GLORIA SOMOLEKAE teaches public administration at the University of Botswana. She received her Ph.D. from Syracuse University. She is completing a study of women in the informal sector and has done numerous analyses of democratic institutions in Botswana. She is the current Coordinator of the Democracy Research Project.

R.T. AKINYELE teaches history at the University of Lagos. Dr. Akinyele is Editor-in-Chief, *Nigerian Journal of Inter-Group Relations*. He is a member of the American Studies Association of Nigeria and Nigerian Folklore Society. He is currently co-editing a book, *The National Question in Nigeria*.

ASAFA JALATA is Assistant Professor of Sociology and African and African-American Studies at the University of Tennessee, Knoxville. He is the author of *Oromia and Ethiopia*, and his articles have been published in *The Journal of Oromo Studies*, *Horn of Africa*, *Dialectical Anthropology*, *The Journal of Political and Military Sociology*, and *Social Justice*.

FRANK A. SALAMONE is Professor of Anthropology and Sociology at Iona College. He has conducted field work in Nigeria on seven occasions since 1970, most recently as a Fulbright Fellow in 1989-1990. He has conducted field work elsewhere in Africa (Ghana and Kenya) and in other areas (Venezuela, the United Kingdom, Canada, and the United States). His most recent book, edited with Bruce Grindal, is *Bridges to Humanity*. He has been most concerned with issues of colonialism, post-colonialism, religion and identity.

AUGUSTINE KONNEH is an Assistant Professor of History at Morehouse College in Atlanta, Georgia. He has researched and written on the Mandingo and Islam in Liberia. He has also written on women and the politics of change in Liberia. His most recent book, *Religion, Commerce, and the Integration of the Mandingo in Liberia*, was published by the University Press of America in 1996.
