The essays included in this volume offer a wide-ranging approach to the eighteenth century, with emphasis mainly on literature and philosophy. The contributors, an impressive roster of scholars from England, the United States, Australia and Canada, provide straightforward and highly intelligent discussions of some important aspects of this century: the meaning of the term "enlightenment," an essay on Hume's ambiguous use of the word "sentiment," studies on Johnson, Swift, and the influence of Milton on eighteenth-century German literature.
