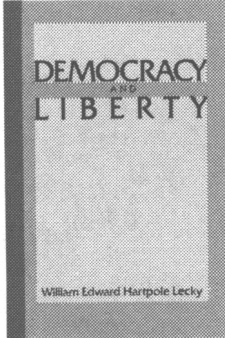

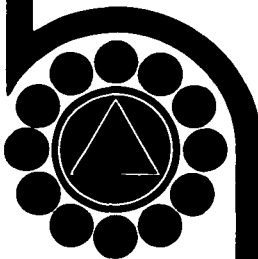

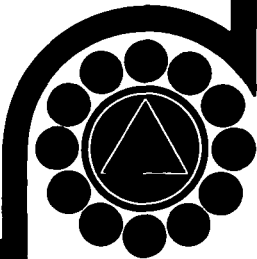

A Deplorable Scarcity

The Failure of Industrialization in the Slave Economy

by Fred Bateman and Thomas Weiss

In this major reexamination of the southern industrial economy and its lack of progress during the antebellum period, the authors show that slavery and its consequences did not by themselves inhibit southern industrialization. Rather, they argue that the planters hesitated to invest in high-risk enterprises and worried that industrialization would undermine their authority. Underpinning this study is a massive new collection of data on the business operations of thousands of industrial producers. These statistics permit economic analyses that were previously unfeasible.

War and Society

For the two years 1982-3 and 1983-4 the subject of the Seminar of the Shelby Cullom Davis Center for Historical Studies at Princeton University will be War and Society. The Seminar hopes to deal with the effects of preparations for war and of war itself upon all aspects of society. This will include theories of war; the culture of war, such as codes of war, military values and military education; military organization, military technology, and their consequences; the effects of military preparations upon governmental and administrative institutions, fiscal policy, economic development, social organization, and mobilization of resources; the results of war in terms of material destruction, human losses, psychological attitudes (xenophobia or peace movements and special pressure groups [veterans organizations]); the long-term and short-term economic benefits of war; and finally the historiography of war.

The Seminar is not interested in the tactics or strategy of war itself.

The Center will offer a limited number of Research Fellowships for one or two semesters, running from September to January and from February to June, designed for highly recommended younger scholars, as well as for senior scholars with established reputations. Candidates who have not both finished their dissertations and had at least a year of full-time teaching experience thereafter are not eligible. Fellows are expected to live in Princeton in order to take an active part in the intellectual interchange with other members of the Seminar. Funds are very limited, and candidates are, therefore, strongly urged to apply to other grant-giving institutions as well as the Center.

Inquiries and requests for Fellowship Application Forms should be addressed to the Secretary, Davis Center for Historical Studies, 129 Dickinson Hall, Princeton University, Princeton, New Jersey 08544, U.S.A. The deadline for fellowship applications and letters of recommendation for 1982-83 is December 1, 1981, and for 1983-84 is December 1, 1982. Scholars who are not applicants for Fellowships but would like to visit Princeton to offer a paper to the Seminar are asked to write to the Director.
