NOMINATION OF MEMBERS FOR ELECTION AS OFFICERS AND AS MEMBERS OF THE COUNCIL OF THE AFRICAN STUDIES ASSOCIATION OF THE UNITED KINGDOM

1. Members are asked to bear in mind Standing Order No. 1 (April 18, 1966, amended February 23, 1979) reproduced below:

Standing Order No. 1 : Nomination of members for election to the Council

1. Not less than three weeks in advance of the day of the Annual General Meeting, the Hon. Secretary shall invite nominations of Members for election to fill the vacancies occurring on the Council at that Annual General Meeting at which the election is to take place.

2. For a nomination to be valid, it should be in writing, bear the signature of not less than four Members as nominators and also the signature of the Member nominated to confirm that he would be willing to serve if elected, and be in the hands of the Hon. Secretary before the start of the Annual General Meeting at which the election is to take place.

3. The Council shall have the duty, after considering the nominations submitted, to make such further nomination as may seem to it needful to secure a due balance of disciplinary and regional interests on the Council.

2. In accordance with this Standing Order, the Hon. Secretary now invites nominations for election to the Council at the A.G.M. to be held on Tuesday, 22 September, 1981.

3. Members are asked to note the present composition of the Council as set out below. There are 7 vacancies for 1981-84 1 vacancy for 1981-83, and 1 vacancy for 1981-82.
