HELVETIUS

A STUDY IN PERSECUTION, *by* D. W. SMITH. Few books evoked a greater outcry from religious and civil authorities than Helvétius's *De l'esprit*. Denigrated as the epitome of all the dangerous philosophic trends of the age, it enjoyed an immense *succès de scandale*. Yet the fascination of the affair lies less in the Catholic reaction to the work's anti-religious ideas than in the latent hostilities which Helvétius provoked and the confusion which he revealed in the ranks of the philosophers. This study is a history of the complicated events of the affair, based largely on unpublished manuscript material; it also analyses the reaction of the Church and the curiously hostile response of the philosophers, particularly the refutations of Rousseau and Diderot. \$6.50.

HERDER'S SOCIAL AND POLITICAL THOUGHT FROM ENLIGHTENMENT TO NATIONALISM

By F. M. BARNARD. Herder's thought marks a decisive stage in the history of ideas between European Enlightenment and the era of modern Nationalism. But whilst its impact on the diverse national movements in Europe is generally recognized, its specifically political and sociological content has received scant attention. The author believes that this neglect is unmerited, for much that Herder had to say on social and political life has lost none of its relevance to current discussions in politics and sociology. In particular, his theory of community, which differed both from the current attitudes of Enlightenment and from the conceptions of such precursors as Rousseau and Justus Möser, is discussed. \$5.50
