A Bibliography of Dissertations on Latin American History, 1960–1970.

In preparation for publication by the Institute of Latin American Studies at the University of Texas at Austin for the Pan American Institute of Geography and History (PAIGH). To be published in 1971; contains approximately 400 entries.

A Bibliography of Theses and Dissertations on Latin America by United States Geographers, 1960–1970.

Comp. by Ernst C. Griffin and Clarence W. Minkel for the Pan American Institute of Geography and History. 1970. 240 entries.

A Bibliography of Theses Dealing with Hispano-American Literature.

Comp. by Sturgis E. Leavitt. 1935. 219 entries. Claims to list all theses on the subject up to 1934. Reprint from *Hispania*, XVIII, No. 2, May 1935.

A Bibliography of Unpublished Doctoral Dissertations and Master's Theses Dealing with the Governments, Politics and International Relations of Latin America.

Comp. by Harry Kantor for the Committee on Latin American Affairs of the American Political Science Association. 1953. Approximately 1,000 entries.

Boletín de Estudios Latinoamericanos.

Published semi-annually by the Centro de Estudios y Documentación Latinoamericanos (CEDLA) of the University of Amsterdam. Representative issue contains 64 titles in the "Sección de investigaciones europeas en progreso sobre

Latin American Research Review

América Latina." Subject areas listed are Anthropology, Economic and Social Development, Economics, and Sociology.

Dissertation Abstracts.

Published monthly; Vol. I—1938ff., by University Microfilms, Ann Arbor, Mich. Series A: Humanities; Series B: Sciences.

Latin American Education Research.

Comp. by Franklin Parker for the Institute of Latin American Studies at The University of Texas at Austin. 1963. 269 doctoral dissertation entries.

Latin American Research at The University of Texas, 1893–1958.

Comp. by the Institute of Latin American Studies at The University of Texas at Austin. 1966. 670 master's theses and doctoral dissertation entries. To be updated at ten year intervals.

List of Doctoral Dissertations in History in Progress or Completed at Colleges and Universities in the United States.

Published every three years, 1911–present. Until 1939, published by the Carnegie Institution of Washington, D.C. Presently published by the American Historical Association. Representative issue contains approximately 200 Latin American titles.

Luso-Brazilian Review.

University of Wisconsin Press. Unpublished doctoral dissertations and master's theses on Brazilian and Portuguese Studies in the United States and Canada.
