The main object of the journal is to publish surveys of recent contributions and developments across the broad spectrum of economics including econometrics and business economics. The journal will enable academic and professional economists to keep up-to-date with major developments in topics outside their main areas of specialisation. Many articles will be accessible to advanced students and the journal will therefore be useful in a teaching environment. The journal's coverage will be broad, though the unifying theme will be to focus on the main issues of a particular area rather than the specific technical details which are often the subject matter of articles in specialised journals.

The primary content of the journal will be two or three **survey articles** per issue, each article between 20 and 30 pages in length depending on the breadth of the topic concerned. In addition the journal will include **book reviews**, reviews of recent **computer software** and there will be a section summarising discussion of particular issues at recent **conferences**.

Two issues will be published in Volume 1 (1987), four issues in Volume 2 (1988) and in subsequent volumes.

As the journal is expected to be widely recommended as reading material for students a special concessionary rate for second and subsequent copies for libraries is available.
