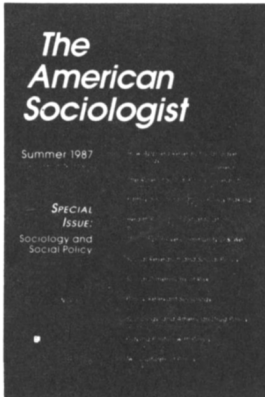

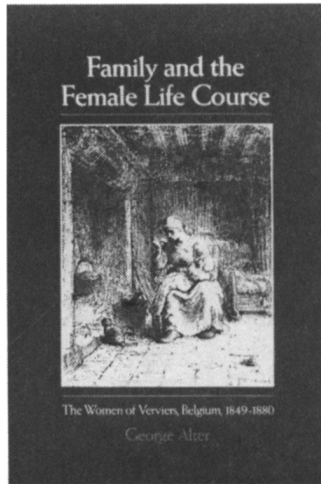

The Women of Verviers, Belgium, 1849-1880

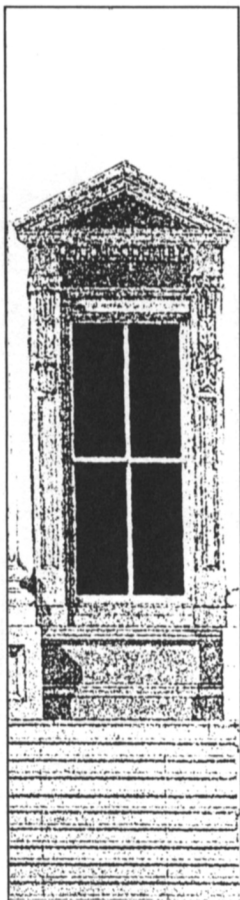
George Alter

The tension between women's workplace opportunity and family obligation is not exclusively a phenomenon of the 1980s, as George Alter makes abundantly clear in this study. His close investigation of women's lives in a nineteenth-century European industrial city advances our knowledge in several areas of social history, historical demography, and life course studies. It is the first monograph to apply event history analysis to the study of family history.

Alter's rich interpretations not only help to reconstruct the past, but place some current social issues into historical perspective—illegitimacy, nuclear family patterns, and women's dual family/work roles, among others.

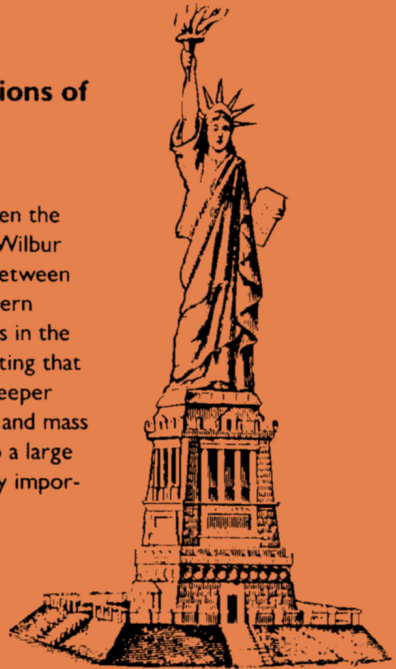
