Susan Coutin is Assistant Professor of Anthropology at North Adams State College. She has studied human rights abuses in Argentina during the last period of military rule, efforts to aid Salvadoran and Guatemalan refugees in the United States, and the 1985–96 trial of sanctuary activists on alien-smuggling charges.
