BRENDA DANET holds a joint appointment in communications and sociology at the Hebrew University of Jerusalem and is currently serving as director of its Communications Institute. From 1971-78 he was jointly appointed in Osgoode Hall Law School and the Division of Social Science, York University, Toronto. He is currently Senior Lecturer in the School of Law, University of Warwick, England.
