### **Hospital groups announce joint venture agreement**

The Board of St Andrew's Hospital, Northampton and Cygnet Health Care plc, Sevenoaks, Kent, has

announced the finalisation of a joint venture agreement by which Cygnet will undertake the management of St Andrew's at Harrow under a long-term contract. Bowden House joined the St Andrew's Group in 1983.

St Andrew's, Northampton, the 367 bed parent psychiatric hospital, was founded over 150 years ago. It operates as an Independent Charitable Trust.

Under the terms of the agreement, Cygnet will undertake the direct management of St Andrew's at Harrow immediately, under a Board with representatives of both groups.
