This book presents the first comprehensive examination of the legal, educational, social, and ethical issues involved in state regulation of nonpublic schools. Differing viewpoints are represented in papers by Governor Harold E. Hughes (Iowa), historian Franklin H. Littell, anthropologist Jules Henry, State Commissioner William Sanders (Connecticut), and William B. Ball, counsel for the National Committee for Amish Religious Freedom. Other papers explore the constitutional framework for public control of nonpublic schools.

This book is a fascinating account of the automobile dealers' long struggle to alter the balance of power between themselves and the large manufacturing corporations. Macaulay's description of the dealers' attempts to find a legal remedy for what they consider unfair practices of the manufacturers shows the part that the legal system plays in implementing, regulating, and hindering economic relationships.

This is a book for anyone interested in law as part of the living process of the society. As such, it is a book for the imaginative practicing lawyer and the realistic scholar—not just scholars of law, but also those interested in the roles of the market and the large corporation. It advances our understanding of the ways in which informal procedures can develop as a result of pressure for changes in the formal rules.

**ADMINISTRATIVE JUSTICE**

—Advocacy and Change in  
Government Agencies

**Philippe Nonet**

This volume is a case study of the interrelationships of law, politics, and administration. It traces the progressive transformation of the California Industrial Accident Commission from a welfare agency with broad discretion in making and interpreting its own policies into a relatively passive arbitrator of disputes over industrial accident claims.

Dr. Nonet uses the case to explore issues in sociological jurisprudence. He examines the effects of the elaboration of legal rules and doctrines, the significance of the procedural aspects of law, and the interplay of legal process and institutional change. This study provides a basis for interpretive generalizations about the relationship of law to organizational and administrative change.
