**Catherine Albiston** is a Ph.D. candidate in Jurisprudence and Social Policy at the University of California–Berkeley and holds a J.D. from Boalt Hall School of Law. She practiced employment law at the Legal Aid Society of San Francisco and served as a judicial clerk for United States District Judge Susan Illston. Her dissertation examines how the legal system, the social institution of work, and other normative systems influence the process of mobilizing employment rights created by the Family and Medical Leave Act. Her research interests include law and social change, law and social institutions, legal and scientific conceptions of evidence, public interest lawyers and organizations, and the relationship between law and social inequality.

**Kenneth G. Dau-Schmidt** is the Willard and Margaret Carr Professor of Labor and Employment Law at the Indiana University–Bloomington School of Law. He received both his J.D. and his Ph.D. in economics from the University of Michigan–Ann Arbor. He undertook his undergraduate education in economics and political science at the University of Wisconsin–Madison. He has written extensively on the economic analysis of labor and employment law and on the interface between sociology and economics in the analysis of legal problems.

**Yoav Dotan** is a senior lecturer at the Faculty of Law, Hebrew University, Jerusalem, Israel. His areas of interest are public law, law and politics, and the study of cause lawyers. His current research involves a study of government lawyers and their relationship with cause lawyers and interest groups.

Pritchett awards of the American Political Science Association. His current research is on administrative legalization, managerial perceptions of legal liability, and the construction of legal rights at the local level.

**Patricia Ewick** is Associate Professor of Sociology at Clark University. She wrote *The Common Place of Law: Stories from Everyday Life* with Susan Silbey. Currently, she and Silbey are studying legal culture, consciousness, and science.

**Donald J. Farole Jr.** was Assistant Professor in the Department of Political Science at the University of North Carolina at Greensboro from 1996 to 1999. He is the author of *Interest Groups and Judicial Federalism: Organizational Litigation in State Judiciaries* (Praeger Press, 1998). His research interests include state judiciaries, judicial federalism, and rights litigation.

**Marc Galanter**, formerly editor of the *Law & Society Review* and president of the Law and Society Association, is the John and Rylla Bosshard Professor of Law and South Asian Studies at the University of Wisconsin and Centennial Professor at the London School of Economics. He has written extensively about lawyers, litigation, and legal culture in the United States and India.

**Joel B. Grossman** is Professor of Political Science at the Johns Hopkins University.

**Susan Brodie Haire** is Assistant Professor of Political Science at the University of Georgia. Her current research projects include an analysis of policy implementation in disability law and a study that explores the linkages between appellate briefs and decisions of the U.S. Courts of Appeals. He is also coauthor with Donald R. **Susan S. Silbey** is Professor of Sociology at Wellesley College. Her recent book, *The Common Place of Law: Stories from Everyday Life* (University of Chicago Press) is coauthored with Patricia Ewick. She has conducted research on a variety of topics, including consumer protection enforcement, lower courts, mediation and alternatives to law, and

most recently the place of law in popular culture and consciousness. She is a past president of the Law and Society Association and is currently at work on a new project comparing normative ordering in law and science.

**Donald R. Songer** is Professor of Political Science at the University of South Carolina. His current research interests focus on decisionmaking on appellate courts and include an ongoing study of the U.S. Courts of Appeals and an analysis of decisions by the top appellate courts of seven nations with English common-law roots. He was the principal investigator for the creation of the Appeals Court Data Base Project sponsored by the National Science Foundation and is the senior author of *Continuity and Change on the United States Courts of Appeals*.

**Loretta J. Stalans** is Associate Professor of Criminal Justice at Loyola University Chicago. Her research interests are in the area of public opinion about justice and domestic violence. She has coauthored with Julian V. Roberts *Public Opinion, Crime, and Criminal Justice* (Westview Press, 1997) and is currently a coauthor with Roberts, Mike Hough, and Dave Indermaur of the forthcoming *Penal Policy, Populism, and Public Opinion* (Oxford University Press). For the last 4 years, she and her colleagues Magnus Seng and Paul Yarnold have been evaluating sex offender probation programs in Illinois, examining compliance with treatment and probation.

**Mark C. Suchman** is Associate Professor of Sociology and Law at the University of Wisconsin–Madison. His primary research interests center on the legal environments of organizational activity in general and on the role of law firms in the development of Silicon Valley in particular. He has also written on organizational legitimacy, on the relationship between institutional and ecological models of organizational communities, and on the impact of changing professional structures on corporate litigation ethics.
