EDDY'S LAW OF COPYRIGHT.

Running to some 400 pages this new book provides comprehensive and reliable guidance to the new law of copyright as embodied in the Copyright Act, 1956. After a General Introduction of 27 pages, describing the background of the Act and the way in which it has reached its present form, the author devotes close on 200 pages to a very detailed narrative in which he explains the meaning and effect of the new provisions, dealing with matters in the same order as does the Act itself. The practical approach of this explanatory section is a notable feature of the book, and its usefulness is added to by summaries of the copyright law operating in other countries such as various parts of the Commonwealth and the United States. The actual text of the Copyright Act, 1956, is then given, with suitable annotations, while an Appendix contains the text of the Brussels Convention and the Universal Copyright Convention. The book is completed by a Table of Cases and a good Index. good Index.

This book replaces the earlier book entitled Hughes on Jurisprudence; it must not, however, be regarded as a revision of that work, for Dias and Hughes is an entirely new work based on a fundamentally different plan. Running to some 500 pages, this new book covers the subject in a way which is interesting for its own sake as well as refreshing for the reader. Special emphasis is placed on helping the student to think for himself and to construct his own concepts, so that the work has an added value resulting from its disciplinary approach. The form of the book makes it suitable for most University courses in Jurisprudence; the bringing together of modern views, including those of continental writers and the realist jurists, will be particularly useful to undergraduates.
