

## ABOUT THE AUTHORS

SUE C. ALEXANDER is a Lecturer in sociology at the University of New England, Australia. She received her B.A. (1965) from Stanford University, her M.A. (1967) from the University of Michigan, and her Ph.D. (1970) from Ohio State University. Her present interests include theories of law and social deviance, the design of social structures for people, and the human potential movement.

GIANCARLO BARONTI is a graduate of the University of Perugia. He teaches cultural anthropology at the University of Perugia. He has written *Fattori di criminalità e quadro sociale della devianza* and various articles on crime, the stereotype of the criminal, and terrorism. He is currently involved in research on the pattern of rural homicides in Umbria in the second half of the nineteenth century. He is a member of the European Group for the Study of Deviance and Social Control.
