This edition of the Manyōshū, containing 1,000 poems, is that of a committee of the Nippon Gakujutsu Shinkōkai, which translated the poems into English.

The poems included come from the Pre-Ōmi, Ōmi, Asuka, Fujiwara, and Nara periods. The poets represent every level of society, from emperors, empresses, and court personnel to soldiers and peasants.

Besides the translations, the cloth bound edition also includes the Romaji texts. Both editions include an introduction which provides the historical and social background of the poems, biographical notes on the poets, a chronological table, and a finding list. There are five maps (four in the paperbound edition) and a frontispiece which reproduces a page from the Katsura manuscript of the Manyōshū.

The memoirs of Baron Harada Kumao reveal the ideas, comments, and activities during 1930-40 of Japan's leading "moderate" or "liberal" statesman, Prince Saionji Kimmochi, in the decade that saw liberal patterns dissolving in the face of aggressive expansion and increasing internal preparation for war.

Dr. Mayer-Oakes has chosen for translation the volume in which Harada details the Japanese power struggle of 1930 over the acceptance of the London Naval Treaty, a struggle centered about the division of civil and military authority. Harada reports the successive steps through which Prime Minister Hamaguchi, with the aid of Saionji and his circle of likeminded men in the court and the high command, thwarted opposition to ratification of the treaty and achieved what was to be proved a fragile victory.

Because of Baron Harada's long association with Prince Saionji as his political secretary, these memoirs bring to life a significant period in Japanese history.

Dr. Mayer-Oakes has been a member of the history faculty at Wayne State University since 1947 except when, on leave from Wayne, he served as a research professor at Tokyo University under the Fulbright program.

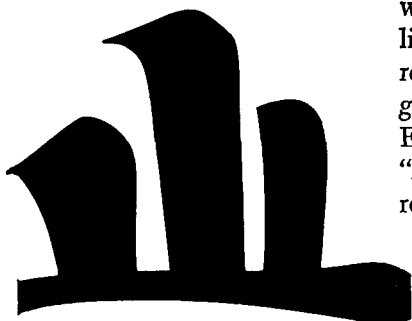

How the Conservatives Rule Japan

The Liberal Democratic party has governed Japan since 1955. Dr. Thayer, who was American press attaché in Tokyo from 1962 to 1965, gives us the first detailed analysis in English of this central structure of postwar Japanese politics, examining in detail the realities of party operation: the role of factions, the party's relations with the economic community, the organization and financing of elections, the selection of a president, the making of the cabinet, and policy- and decision-making within the party.

The major theme of this study is the growing effectiveness of the party within the context of Japanese political life. Dr. Thayer believes that this growth is reflected in a gradual shift from politics based on the strength of individual personalities to a greater emphasis on the party as an institution.

To those interested in modern Japanese politics, this book offers an intimate picture of the Liberal Democratic party both in its daily workings and in its long-term development, one which draws its immediacy from interviews with party members and members of the Japanese press as well as from personal observation. Political scientists generally will find material for comparisons of electoral behavior, factionalism, and other aspects of political decision-making in this sensitive and informed account of the governing body of the first mature parliamentary democracy outside the Western world.

Mental Health Research in Asia and the Pacific

Edited by William Caudill and Tsung-yi Lin

How have Asian countries made use of, adapted, and developed psychiatric theories and techniques from the West? How have such theories and techniques been used in Asian countries to further understanding of the similarities and differences in the behavior of people in various cross-cultural settings? Only through an international cross-cultural forum would it be possible to reach some agreement with regard to the common denominators in human behavior regardless of biological, social, and cultural differences in national populations.

This new work is the result of such a conference on Mental Health Research in Asia and the Pacific held at the East-West Center, University of Hawaii, in the spring of 1966. Although other conferences had previously focused on mental health needs, personnel resources, and training, it is believed that this one represented the first time that Asian and Western psychiatrists and social scientists from many countries sat down together specifically to discuss problems and results of research on mental health.

The major sections of the book are addressed, first, to issues in the identification and study of mental illness, and second, to the effects of social structure and culture on human behavior. The concluding section offers an overview and criticism of the content of the preceding sections and makes suggestions for research and training in the future.
