CONTRIBUTORS

Frances Hill is an Assistant Professor of Government at the University of Texas at Austin. A specialist in comparative agrarian political economy, her interests range from Africa to the United States to the relations between them. Her *Ujamaa: Mobilization and Participation in Tanzania* (London: Cass, 1978) will be followed by a book on American agriculture. Her current research focuses on U.S.-African agricultural trade and issues of international dependency.

Peter R. Knauss is an Assistant Professor of Political Science at the University of Illinois at Chicago Circle.
