In this book, Pryor and Schaffer present data showing that jobs requiring a high level of education are increasing more slowly than those requiring somewhat fewer educational credentials. Additionally, the authors show how women are replacing men in jobs requiring higher levels of education. Using these insights the authors also explain why wages have become more unequal, why wages in those jobs requiring extra-high cognitive skills have risen and why all other wages have stagnated or fallen in the past quarter century.
