trips designed to provide additional opportunities for direct exposure to American politics, government, history, and culture. These include a day spent viewing the government and public works projects of the City of Carbondale, a half day spent observing the federal district court for the region, several visits to campaign stops of the candidate for state senate who served as codirector, a very full day spent touring a not-forprofit hospital located in East St. Louis, Illinois, and a visit to the Fourth of July celebration and historical sites in a nearby small town.

Moves toward Normalization with Cuba Include Liberalization of Scholarly Exchanges

President Clinton's January 5 announcement of "measures designed to ease the plight of the Cuban people and help them prepare for a democratic future" included a pledge to expand "people-to-people contact through two-way exchanges among academics [and] scientists." A small step in the slow but steady easing of America's economic and cultural pressure on Cuba, the expansion of scholarly exchanges flows directly from 1992's Cuba Democracy Act, which calls for such steps, and continues a recent trend in which American scholars have been granted much fuller and more frequent access to Cuban archives.

AAUP Study Finds Women Faculty at Disadvantage in Rank, Pay

According to a report published in the January–February 1999 issue of *Academe*, female faculty tend to earn less and be promoted less frequently than their male colleagues, regardless of discipline or institution. According to data compiled by Ernst Benjamin, director of research for the American Association of University Professors, women, who comprised 33.8% of college and university faculty in 1997–98, held 55.6% of lectureships, 58.6% of instructorships, 46.8% of assistant professorships, and only 18.7% of full professorships. The study also found that women more readily accept low-paying positions and appointments at low-prestige institutions than do men, but offered no explanation for this finding. National Archives Making Plans to Expand Retention of Electronic Records

In response to a U.S. District Court ruling of October 1997 that nullified regulations that allowed it to destroy electronic programmatic records from most government agencies if comparable paper records existed (*Public Citizen v. John Carlin*, Civil Action No. 96-2840), the National Archives and Records Administration (NARA) is devising procedures for collecting and preserving such records. Although NARA is appealing the ruling, it plans to issue guidelines for submitting and cataloging electronic records to agencies in March 1999. The proposed guidelines would give agencies six months to 21/2 years to comply, which the plaintiffs in the original case—including the American Library Association, the American Historical Association, and the Organization of American Historians—have argued is too long.

Political Analysis

The field of political methodology has become quite a success story. Our summer meetings started out with a dozen participants 15 years ago and now is over 100. The quality and quantity of our scholarship is far superior to what it once was. Our members now have representation on the editorial boards of every journal in the discipline that would be relevant to our work. Methodologists now hold jobs at virtually every research university and college in the country, and our courses are taught to every graduate student and undergraduate. All the speciality lacks is enough publication outlets for those creating methods, adapting methods from other disciplines, doing highly sophisticated empirical analyses, and advancing related developments in formal theory. Our hard-working publications committee made a number of recommendations, and, after a good discussion at an unusually well-attended business meeting, unanimously approved our plan.

The plan is to expand *Political Analysis* to a more presti-

The plan is to expand *Political Analysis* to a more prestigious, visible, and aggressive quarterly journal, and to increase section dues to cover the cost of sending issues to all our members.

After extensive negotiations with several presses competing for our business, I recently signed a contract with Westview Press, now a subsidiary of Perseus Books (they own Basic Books, among others). The main features include:

1. Political Analysis will appear on a very regular schedule, every quarter, with the first issue due in the fall of 1999. Submissions have already begun, and our new editor, Nathaniel Beck (beck@ucsd.edu), encourages you to contact him if you have any questions.

2. Time from final delivery of accepted manuscripts to ublication and mailing will be only 4 months at the start and 3 months after an issue or two. This means that the turnaround time from acceptance to publication will be very fast.

3. The Section will pay \$15 per member per year to have four quarterly issues of *Political Analysis* mailed to them. Section dues will therefore increase to \$25 when the journal starts publishing. In addition, any graduate student who feels they cannot afford the increase is encouraged write a letter to our secretary-treasurer and will receive a \$15 refund, hence making our dues the same as most other sections. This is an outstanding deal for individuals receiving a journal (far less than other proposals we've received, and less than even the student rate for most existing journals). It is also terrific deal for the field, since we will have a major journal instantly, with the prestige of the section membership behind it.
