

## **ABOUT THE AUTHORS**

UPENDRA BAXI, Professor of Law at the University of Delhi, received his J.S.D. degree from the University of California at Berkeley. From 1968 to 1972 he devised and conducted post-graduate courses in legal sociology at the University of Sydney, Australia. He has served as a member of the Research Advisory Committee on Law and Development of the International Legal Center, New York and is currently the Coordinator for the Development of Sponsored Research Programmes of Law and Social Change with the Indian Council of Social Science Research. He has published several papers on Indian law and constitution and has recently completed a major study of law and development research in India.

BRUCE BULLINGTON is Assistant Professor of Law Enforcement and Corrections at the College of Human Development, Pennsylvania State University. He recently received his Ph.D. in Sociology from the University of California at Los Angeles. His interests are in criminology (especially drug abuse) and the sociology of law, and he has published in *Social Problems*, *American Journal of Public Health*, and other journals.

STEPHEN C. HALPERN received his Ph.D. in political science in 1973 from The Johns Hopkins University. He is Assistant Professor of Political Science at the State University of New York at Buffalo, and the author of a forthcoming book, *Police Association and Department Leaders: The Politics of Co-optation*, to be published by Lexington Books of the D. BARTON L. INGRAHAM is Assistant Professor of Criminal Justice and Criminology at the University of Maryland, College Park Campus. JONATHAN POOL is Assistant Professor of Political Science at the State University of New York at Stony Brook. His substantive and methodological interests include the politics of language, political attitudes, cross-cultural survey research, and computer-based decision-making experiments. He has contributed to *Advances in the Sociology of Language*, *Advances in Language Planning*, and *Handbook of Soviet Social Science Data*. Currently he is editing a book on the politics of language and is spending the 1974-75 year on leave for research and training at the University of Mannheim and McGill University.

H. LAURENCE ROSS is Professor of Law and Sociology at the University of Denver. His principal research interests are in the operation of informal legal processes and in the impact of law on behavior.
