Applied Psycholinguistics is an international journal which publishes papers on the psychological processes involved in language. Articles address the nature, acquisition, and impairments of language expression and comprehension, including writing and reading. Specific topics are diverse: psycholinguistic processing, language acquisition, language disorders in children and adults, development of speech perception and production, bilingualism and second language learning, acquisition and use of sign language, studies of language and cognition, processing connected discourse, assessment of communicative competence and of linguistic maturity, reading and writing disorders, the development of literacy, and language disorders associated with autism, mental retardation, emotional disturbance, environmental deprivation, specific learning disabilities, and hearing impairment.

In addition to research reports, problem-oriented reviews of important or emergent areas will be considered for publication, as will short notes, discussions of previously published papers, book reviews, and methodological notes. The journal will occasionally publish issues devoted to single topics within its purview, and will also consider publishing the proceedings of symposia or small topic-centered conferences.
