Diary of a Madman and Other Stories

Lu Xun

The inventor of the modern Chinese short story, Lu Xun is universally regarded as twentieth-century China's greatest writer. This long-awaited volume presents all of Lu Xun's stories in new translations that faithfully convey both the brilliant style and the pungent expression for which Lu Xun is famous. Also included are a substantial introduction by the translator and sufficient annotation to make the stories fully accessible, enabling readers approaching Lu Xun for the first time to appreciate why his stories have come to occupy a permanent place not only in Chinese literature but in world literature as well.

Chinese Lyricists of the Seventeenth Century

David R. Mc Craw

The seventeenth century saw the collapse of a Chinese dynasty and the imposition of alien rule in China. David Mc Craw's introduction outlines the historical setting and describes the cultural matrix that engendered the rebirth of the lyric genre in that turbulent age. From the martyr Chen Zilong and the turncoat Wu Weiye to the philosopher Wang Fuzhi and the esthete Chen Weisong, the early Qing lyricists responded in various ways to the pressures of the time but were united in their devotion to their art. The book concludes with the "new men" who enjoyed favour at the Qing court - the southern erudite Zhu Yizun and the Manchu officer Nalan Singde, arguably the greatest lyricist of the age.
