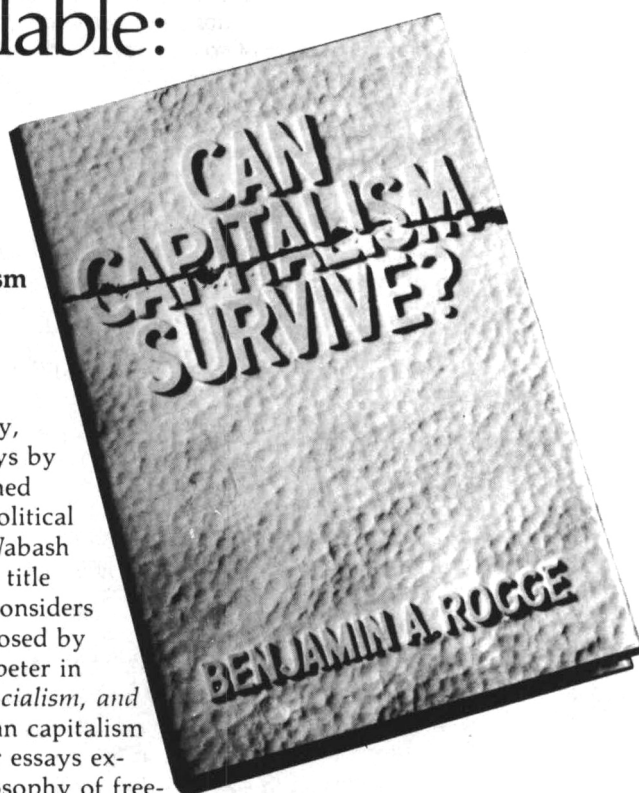

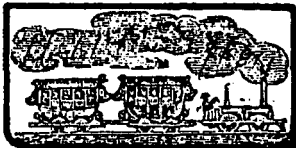

Organized in 30 short, manageable chapters and some 200 pages shorter than in the Third Edition, the book discusses such themes as agriculture, industrial growth and development, the impact of the Depression on the nation, and the modern problems of employment and technological change. The first half of the book has been extensively revised to offer more complete coverage of the Colonial, Early National, and Middle Periods — including new research on division of wealth, colonial shipping, and slavery.
