

New APSA Officers Elected

APSA President Lucius J. Barker presided at the Association's 1993 Annual Business Meeting September 4, where new officers were elected.

Sidney Verba, Harvard University, was elected president-elect; he will assume the office of president in 1994-95. David Brady, Stanford University; Paula McClain, University of Virginia; and Ronald Rogowski, University of California, Los Angeles, were elected to two-year terms as vice presidents.

Susan Bourque, Smith College, was elected to a three-year term as treasurer and John Aldrich, Duke University, was elected to a one-year term as secretary. Travel Grants for Foreign Scholars Attending Annual Meeting

Fifty-eight foreign scholars were the recipients of travel grants to attend the 1993 APSA Annual Meeting in Washington, DC. Foreign graduate students attending U.S. universities were selected competitively and received travel money made available by the Huang Hsing Foundation, The Asia Foundation, and the APSA Council. More senior scholars who had been invited to participate at the Annual Meeting were also awarded travel funds by the APSA Council. Additional senior scholars were awarded travel grants through the United States Information Agency to participate in the Annual Meeting.

As part of a continuing exchange between APSA and the Japan Political Science Association, four Japanese political scientists attended the Annual Meeting and presented papers. The exchange program is supported by a grant to the APSA from the Japan-U.S. Friendship Commission, and is now in its fourth year of operation.

APSA's Bunche Students Attend Annual Meeting

Eight of ten students participating in the Ralph Bunche Summer Institute attended the APSA's Annual Meeting. The students were recognized at the reception given by the Committee on the Status of Blacks in the Profession.

The Bunche Institute is hosted by a consortium of five Atlanta institutions: Spelman College, Emory University, Morehouse College, Clark Atlanta University, and Georgia State University. This year ten outstanding African American undergraduates who have demonstrated potential in the field of political science were selected to attend the six-week program whose purpose is to encourage enrollment in graduate school. This year students from ten different academic institutions attended the Bunche Institute. Dr. Jeanne T. Meadows of Spelman College was the director of the 1993 Institute.
