Yoshiaki IKEDA was born in 1936 and teaches at Kobe Gakuin and Shizuoka universities. He has been invited professor at the Leibniz Archives in Hanover. He holds the chair in European philosophy at Ritsumeikan University in Kyōto. He directs the Institute for Research on Integrated Science.

Hisakazu INAGAKI, a professor at Tokyo's Christian University, studied civil and social philosophy at the Free University in Amsterdam. He is the author of several volumes of philosophy, among them: *Philosophical Theology and East-West Dialogue* (Amsterdam 2000).

Yoshiko KANAI is professor of philosophy in the literature department of Rissho University. She made a remark with a critical mind to crosslink feminism and philosophy in both domains. Among her recent works: 異なっていられる社会を (2008), 依存と自立の倫理 (2011), ファミリー・トラブル (編著 2006), 身体のアイデンテイティ・トラブル(編著 2008).

Nobuo KAZASHI is professor of philosophy at Kobe University, and holds a PhD from Yale University. His main fields of interest are contemporary continental philosophy, pragmatism, modern Japanese thought, and peace studies. In 1991 the American Philosophical Association awarded him the 6th William James Prize for his comparative article on James and Merleau-Ponty. Based in Hiroshima, he has been involved in the international campaign to ban depleted uranium weapons.

Sakiko KITAGAWA is a professor at Tokyo University and on sick leave now. She has published several essays on the writings of Georg Simmel and Martin Heidegger as well as the theme of violence associated with historical memory. In 2006 she helped to set up the Asian Women's Network.

Hisao МIYAMOTO, a Dominican, is an emeritus professor from Tokyo University and a professor at Sophia University in Tokyo. Among his recent publications are: 他者の甦り(2008) and 存在の季節 (2002), as well as the article «ハヤトロギアと西欧存在神論 », in パトリスティカ (2, 2006).

Masahiro MORIOKA is a professor of philosophy and ethics at Osaka Prefecture University and the author of many volumes on the philosophy of life. Among his recent works are: 感じない男 (2005), 33個めの石:傷ついた現代のための哲学(2009),無痛文明論 (2003),生命学に何 ができるか(2001).

Ken-ichi SASAKI, Professor Emeritus at Tokyo University, teaches at Nihon University. A former president of the International Association of Esthetics and the Japanese Society of Esthetics, he is a member of the Steering Committee of the International Federation of Philosophical Societies. Among his published works are: $\mathcal{PT} \mathcal{PD} \mathcal{PB} \mathcal{D} \longrightarrow \mathcal{PF} \mathcal{A} \cdot \mathcal{PA} \mathcal{PB}$ (2001), *Aesthetics on Non-Western Principles* (1998), 美学辞典 (1995), 作品の哲学 (1985) and \mathcal{PDS} . \mathcal{O} 構造 (Suntory Academic Prize 1983).

Yutaka TANAKA, born in Tokyo in 1947, teaches philosophy at Sophia University, where he directs the doctoral school. He is the president of the Japan Society for Buddhist-Christian Studies, and also the president of the Japan Society for Process Studies. Naoshi YAMAWAKI is professor of public philosophy and social thought in the department of advanced social and international studies at Tokyo University (Komaba).
