Political Change in Rural Turkey: Erdemli

This work traces the development of political activity in a closely knit village group of Southwestern Turkey where, in a little over thirty years, the nomad has become a truck gardener. On a fertile coastal strip between the Taurus Mountains and the Mediterranean these people have moved from a nomadic, isolated, tribe- and tradition-oriented society hostile to innovation and pursuing its centuries-old calling of animal husbandry to a settled agricultural society learning to manipulate the new techniques of both cropfarming and politics.

In the late nineteen fifties Dr. Szyliowicz lived in this community, and came to know its way of life, its people and their leaders, its goals and its accomplishments. He has compared his own findings with those of a study of the same group made in 1941 when the tribes of the area were first settling down, and he has thus dramatically documented the stages of change taking place in rural Turkey.

In this work, the author shows how communication has broken down isolation, how increasing contacts have created new needs and wants which have in turn spurred the villager to accept technical innovation. He emphasizes the importance of the emergence of the multi-party system which has resulted in strong competition for the vote of the villager among the numerous candidates for office, which in turn has forced Turkish politicians to focus their attention on rural interests. The villager, on his part, has learned to think of the government not as a far-off, hostile entity, as his fathers did, but as a system of which he is a part and which he can influence. When making his choice of leaders he is beginning to replace the allegiance to kinship and traditional values with economic ones. Thus he has moved from a closed society to a more open one, and as he learns to mesh the gears that run this larger society, a measure of democracy is being born.

What has happened in Erdemli is a concrete example of the latest stage in the Westernization of Turkey—the Westernization of the villager and his active entry into the Turkish political arena. Dr. Szyliowicz' study is a valuable aid in any attempt to understand the stresses of the political situation in Turkey today.
