Professor Louis B. Sohn next presented the report of the Committee on Study of Legal Problems of the United Nations (printed below in the Appendix), dealing in detail with the establishment of the United Nations Emergency Force in connection with the Suez Canal crisis, and reviewing the history of efforts since the war of 1914–1918 to establish an international police force.

The report of the Committee on Selection of Honorary Members was next presented, and its recommendation that Dr. Hans Wehberg, Editor of Die Friedenswarte and Professor at the Institut des Hautes Etudes Internationales in Geneva, be elected an honorary member of the Society was adopted by unanimous vote.

Mr. Denys P. Myers presented the report of the Committee on Publications of the Department of State and the United Nations (printed below in the Appendix), and in that connection offered the following resolution, which was adopted upon motion duly made, seconded and carried;

PUBLICATIONS OF THE DEPARTMENT OF STATE AND OF THE UNITED NATIONS

Whereas, The American Society of International Law has since 1929 reviewed the status of the publication program of the Department of State with a view to supporting and developing the system of issuing documentary material essential to the understanding of the foreign relations of the United States; and

Whereas, The Department of State has been responsive to these annual representations and the Congress in recent years has progressively recognized the importance of such programs as submitted in the budgetary estimates; and

Whereas, The members of the Society have a similar need for adequate publication by the system of the United Nations of materials pertinent to their professional requirements; therefore,

Be it resolved by the American Society of International Law:
