This book introduces a new method for the discovery of truth and fundamental concepts which embrace the physical and spiritual aspects of the universe and man.

The method of science is that of resolving the objects of sense perception into their fundamental constituents (atoms, cells, organisms and man), this method follows the order and regularity of the genesis of these fundamental units in their building of the phenomenal world.

This knowledge, called by its author Knowledge of Creation and Genesis, is based on the assumption that the energy constituent of matter and the spirituality of man's mind, are one and the same. It uses intuition and intellectual vision as the key to our spiritual and creative nature, making it possible to discover principles of creative regularity in the spiritual reality beyond the phenomenal world, the object of science, and upon these principles to explain both creation and genesis of the multiplicity of phenomenal forms, as well as the creation and genesis of mental faculties in animals and the intellectual, moral and aesthetic characteristics in man.

Since the work deals with observational facts of nature it can be classified as science, inasmuch as its aim is to unite the various sciences in order to render a unified conception of nature as a whole, it belongs to philosophy.

It is, on the other hand, not like science because it uses neither sense perception and observation nor analysis and experiment, and is unlike philosophy because reason is not its method of discovering truth.
