The Environmental Impact Statement Strategy of Administrative Reform

Serge Taylor. The central concern of this book is the social intelligence that goes into environmental decisions—how environmental impacts can be recognized beforehand so that less costly trade-offs can be explored, relative risks assessed, and choices made in a manner acceptable to both the public and the government. The book evaluates the first 10 years of the Environmental Impact Statement process of the 1969 National Environmental Policy Act—in particular how it has worked in the Forest Service and the Army Corps of Engineers. It assesses how successful the EIS process has been in establishing a concern for environmental values in the federal bureaucracy, and how widely applicable the general impact statement approach is in other policy areas. \$29.50

Questions, Answers, and Experts

The *Policy Studies Journal* and the *Policy Studies Review* are designed to raise questions and offer answers. In doing so, both periodicals call upon experts on the general approaches and specific policy problems involved in policy studies. Some of the questions that have been addressed in recent issues of *PSJ* and/or *PSR* include:

1. How can one determine the effects of alternative public policies?
2. How can policy evaluation be used to maximize societal benefits minus societal costs in choosing among alternative policies?
3. How can we facilitate the utilization of policy evaluation research by policy-makers and policy-appliers?
4. How can governmental institutions be made more effective, efficient, and equitable in formulating and implementing policy decisions?
5. How can we facilitate more interaction across academic disciplines that are relevant to policy evaluation?
6. How can we facilitate more comparisons across nations, states, and cities concerning alternative public policies?
7. What policies are most appropriate for facilitating international peace and mutually beneficial trade relations?
8. How can we minimize inflation, unemployment, poverty, crime, discrimination, pollution, disease, and illiteracy through more effective public policy?
9. How can we maximize food, energy, technological innovation, freedom of communication, fair judicial procedure, and productivity through more effective public policy?
10. What goals should public policy be seeking to achieve and what obligations do policy analysts have for achieving those goals?
