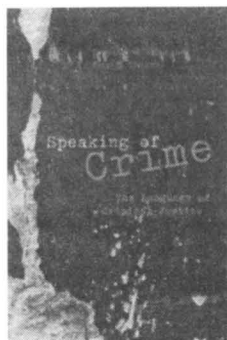

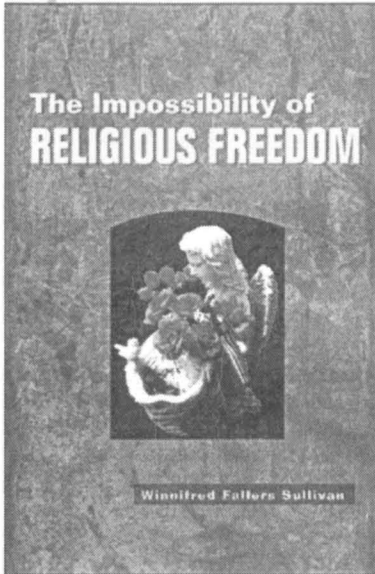

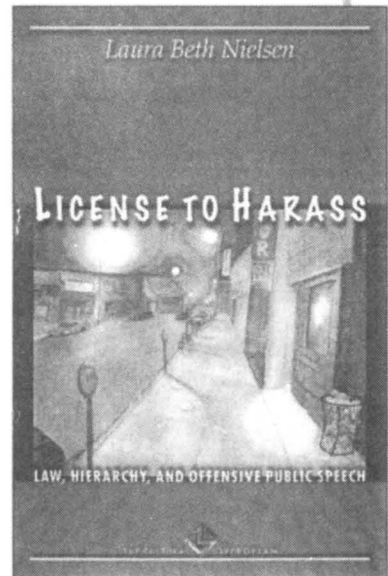
Law, Hierarchy, and Offensive Public Speech
