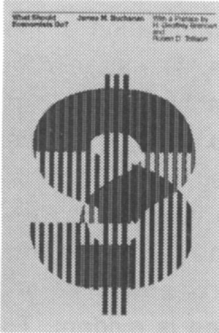
BEYOND DOGMA AND DESPAIR: Toward a Critical Phenomenology of Politics

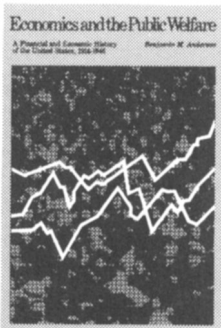
